

Our current plan to deal with the COVID pandemic for EAAP 2021 in Davos

- Physical meeting in Davos with a comprehensive health protection scheme to avoid any health risks (distance, masks, regular disinfection, tracing of participation in sessions, 2 shifts for coffee and lunch breaks).
- Authors of papers are expected to be physically present in Davos. In case traveling to Davos will not be possible for a speaker at the time of the meeting, the theatre presentation could be given virtually (prerecorded, video call for discussion).
- Posters are displayed on a virtual platform (similar to the virtual EAAP 2020 meeting). No traditional poster session with physical posters to avoid crowds. Discussion of posters during the regular theatre sessions.
- Throughout the conference, all 11 parallel theatre sessions will be streamed live for participants who cannot attend the conference in person. 3 parallel sessions will be fully hybrid, 8 parallel sessions will be streamed with a simple setup. Participants will also have electronic access to all posters throughout the event.
- Full refund of registration fee without administration fee is guaranteed in case we would need to cancel the physical meeting. In this case, a virtual meeting will be hosted by EAAP and abstracts submitted for the Davos meeting will be integrated. In case of inability to attend due to official COVID regulations authorities (proven by official documents by the participant): Change to virtual participation without administration fee. <https://www.eaap2021.org/registration>
- This plan will be adapted depending on the developments of the pandemic.

Amendment and cancellation policy

Amendments

Amendments or the booking of additional offers is free of charge. Name changes are subject to an administrative fee of CHF 70.- and only possible prior to the cancellation of the preceding booking.

Cancellation

- **related to Covid-19**
 - In case of **inability to attend due to official COVID regulations of authorities** (proven by official documents by the participant which should be sent to the Organizing Secretariat (Organizers) by email: registration@organizers.ch): Change to virtual participation and difference in registration fee fully refunded without administration fee.
 - In the event of **cancellation by the organizer**: Full refund without administration fee.
- **in all other cases**

The following terms and conditions are applicable:

 - Starting 24h after booking: Full refund, excluding administration fee of CHF 70.-
 - From 1st of July 2021: 50% refund
 - From 1st of August 2021 or if the participant fails to attend: no refund
 - Double bookings or bookings, that are cancelled within 24h after the initial booking are free of charge.
 - In the event of cancellation by the participant, written notification should be sent to the Organizing Secretariat (Organizers) by email: registration@organizers.ch.
 - Name substitutions are possible at an extra charge of CHF 70.
